

Land Acknowledgment

We would like to begin by respectfully acknowledging that Dufferin County resides within the traditional territory and ancestral lands of the Tionontati (Petun), Attawandaron (Neutral), Haudenosaunee (Six Nations), and Anishinaabe peoples.

We also acknowledge that various municipalities within the County of Dufferin reside within the treaty lands named under the Haldimand Deed of 1784 and two of the Williams Treaties of 1818: Treaty 18: the Nottawasaga Purchase, and Treaty 19: The Ajetance Treaty.

These traditional territories upon which we live and learn, are steeped in rich Indigenous history and traditions. It is with this statement that we declare to honour and respect the past and present connection of Indigenous peoples with this land, its waterways and resources.

County

• Operational work going on in the background to look at and action items that came from the staff equity audit. The County is taking the work on D&I very seriously.

EYCC

 Continue to successfully implement the national childcare strategy (referred to as Canada Wide Early Learning Child Care Agreement). Work ongoing at a provincial level to create the funding model for 2024. Concerns that there won't be enough money to make it happen.

Housing

 Deputy Premier came out to Edelbrock April 13th to announce more funding for the Homelessness Prevention Program (HPP). The new funding is meant to help Service Managers create more affordable housing, however the amount provided does make that exceedingly challenging and the funding now also has to provide for supportive housing.

Ontario Works

• Waiting to meet the New Service System Manager "Serco Canada" for the new integrated employment services to be in place by January 1, 2024.



Update on the Landscape from Heather's desk

- May 6th Bridges event, Saturday, Alder Street Arena starting at 8:00 am till 3:00 pm. Breakfast and Lunch are included in the price.
- OFB access increase 41% over March 2022, know only 20% of people in need will access, 80% do not, tracking for those who own a home to show depth of impact
- Food purchasing doubled, County contributing \$50,000, Orangeville \$25,000
- 170 Volunteers hiring a warehouse manager to direct staff to get food out to the community
- Heather's dream bigger building for greater distribution of 700,000 pounds of food


