Contact/Requests

Initial Contact: DCEC Working Groups & Dufferin community groups/organizations interested in consulting with VOICES are welcome to initiate the process by emailing their inquiry or request to the VOICES group with the subject **[REQUEST for VOICES]**. Our email is:

Please make sure your email has a clear question or request for feedback. You can also start with an inquiry if you are not sure if we are a good fit. Your email should also include a contact name and telephone number, with any additional contact instructions such as preferred method of communication and time availability (for phone calls). We look forward to hearing from you!





Consultation Process

Consultation Process: Upon receiving the initial inquiry, the VOICES coordinator will present the request to our group during scheduled meetings (we only meet weekly for 2-3 hours) which impacts our speed. We apologize. Our group will collaboratively work on a response by leveraging our lived experiences. A response is given in writing unless otherwise discussed or requested. Our members are anonymous, so we are not likely to invite you to our meetings or attend yours, unless otherwise pre-approved by the group members.





Timeline

Timeline: The approximate date of the response will be communicated by the VOICES coordinator and will depend on the availability of the group and size of your request. Flexibility is encouraged to accommodate the diverse schedules of VOICES members and the limited amount of time that our group meets. We only meet 3 hours per week, which can impact the turnaround time. Please note, we are not meeting in February 2024. Please let us know if your request is time sensitive so that we can prioritize you as much as possible.





Expectations

Lived Experience Dufferin strives to offer valuable recommendations and share insightful experiences, there is no expectation that the suggestions provided must be adhered to. The purpose of sharing these perspectives is to offer a unique and authentic lens of lived experience on issues related to poverty, equity, and community, with the hope that the information proves useful and supportive. VOICES understands the diverse nature of decision-making processes and recognizes that each group, individual, or organization operates within its own framework, budgets, and constraints.


